

# REQUEST FOR EXPRESSION OF INTEREST (Consulting Services – Individual Consultant Selection)

# Selection of an Individual Consultant to Serve as a Technician civil engineer for building structures and maintenance services

#### Reference No.1-ECW/ADM-MAINT/TCE/24-10/dy

The ECOWAS Commission intends to use part of his budget to finance the service contract for the Selection of an Individual Consultant to Serve as a Technician civil engineer for building structures and maintenance services.

- 2. Under the overall supervision of the head of Maintenance unit of the ECOWAS Commission, the Consultant will ensure the execution of the day-to-day to help boost its Maintenance Unit's capacity to handle construction monitoring and the numerous maintenance challenges.
- 3. The consulting services ("the Services") include the deliverables listed under paragraph 4 below and the duration of the contract shall be for a period of one (1) year from the date of the signing of the contract and could be renewed upon satisfactory appraisal.
- 4. Duties and responsibilities of the consultant: The tasks of the Consultant include the following:
  - Interpretation of construction drawings and specifications for building works;
  - Buildings with block work, bricks and structural concrete;
  - Both wooden and steel portal frames and trussed roofing structures;
  - Installation of electrical and mechanical services (air conditioning, water, computer network and telephone, generators, firefighting services) in low rise buildings;
  - Concrete works including the use of mass concrete and structural concrete;
  - Measurement and quality control in building construction and maintenance;
  - Management of site to ensure the safety of public and staff involved in the construction process;
  - Perform project planning activities, scheduled, and unscheduled corrective interventions, including drafting of scope of work, material schedules, collecting quotes and cost for maintenance activities of buildings;
  - Undertake any further instructions that may be directed by the head of Unit;
  - Prepare reports on monitoring/inspection activities.
- 5. The ECOWAS Commission now invites eligible Individual Consultants ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. *The shortlisting criteria are as follow:*

## **Educational Qualification**

 Must have at least an HND or BAC+2 in Civil Engineering and membership of a professional institution or any other equivalent degree from a recognised university;



#### Experience

- Must have at least 5 years' experience in either building construction or maintenance with Nigerian, British or American Design Standards in use;
- Must have executed at least two (2) similar assignments as Technician civil engineer for building structures and maintenance services;
- Must have executed similar experience as Technician civil engineer or similar roles in the other laboratory testing of soils, concrete, and bituminous products to assure compliance with stated specifications;
- Must have strong IT/ Computer Skills (Microsoft Office suite) and knowledge of relevant software related to basic administrative.

### Language

The Individual Consultants shall be fluent (reading, writing, speaking) in one of the ECOWAS Official Languages (English, French or Portuguese). Practical knowledge (reading, writing, speaking) of any other of the ECOWAS Official language (English, Portuguese or French) would be an advantage.

**NB:** The attention of interested Individual Consultants is particularly drawn to **Article 118 of the ECOWAS Revised Procurement Code ("Infringements by Candidates, Bidders and Awardees")**, providing information on corrupt or fraudulent practices in competing for or executing a contract.
