Summary of Scope of Contract Awarded:

The main scope of the contract is to prepare the architectural, civil engineering and structural design including drawings, specifications, priced and unpriced bill of quantities (BOQ) for the construction of spilt Joint Border Post (JBP) at Jendema border on the Republic of Sierra Leone side and at Bo-Water Border on the Republic of Liberia side. The assignment will include determining the JBP model for the Border Post sites in accordance with ECOWAS functionality study report.

The study covers the Technical, Financial and Legal (compliance with local construction laws, regulations, standards and rules) aspects, including security issues, Topographical and Investigations of the site identified for establishing the JBP. Technical studies for the establishment of the JBPs shall include an environmental evaluation whose recommended mitigation measures must be considered during the civil works.

The study will also take into consideration the availability and accessibility of materials and expertise in the respective local markets of Republic of Liberia and Republic of Sierra Leone.
