



WORLD BANK DIGITAL TRANSFORMATION FOR AFRICA WESTERN AFRICA REGIONAL DIGITAL INTEGRATION PROGRAM (DTfA/ WARDIP) SOP-1 Terms of Reference for a Monitoring and Evaluation (M&E) Specialist of the Regional Project Implementation Unit (PIU)

Background

- 1. The World Bank is financing the implementation of the Digital Transformation for Africa/ Western Africa Regional Digital Integration Program (DTfA/WARDIP SOP-1). The objective of this program is to increase broadband access and usage in participating countries and to advance integration of digital markets in Western Africa.
- 2. The first Series of Projects under this grant (DtFA/ WARDIP -SOP1) has The Gambia, Guinea, Guinea-Bissau, Mauritania, ECOWAS, African Union and the Smart Africa Alliance as beneficiaries. At the ECOWAS level, the goal of the project's activities is to create an integrated regional digital market and to foster cross-country collaboration and support the development and security of digital transformation in Western Africa. Funding for the project is USD 10.5 million over a five (5) year period from 2024 2028. The components of the project which will be executed by ECOWAS include the following:
 - a. **Connectivity Market Development and Integration**: This component aims to develop and integrate the regional connectivity market in a way that encourages private sector competition and investments. Market failures in the telecom sector will be addressed by (i) strengthening the policy and regulatory framework to foster a leveled playing field, (ii) harmonizing digital market environment and sector policies to ensure cross-border interconnection of networks and services, (iii) providing catalytic public funding to connectivity infrastructure PPP projects to increase the resilience of international and core backbone connectivity, and (iv) coordinating between stakeholders to stimulate private investment appetite. This component is also designed to establish a framework for energy-efficient and climate-resilient digital infrastructure-related investments in the region.
 - b. **Data Market Development and Integration:** This component aims to build trust in online transactions and strengthen the security and resilience of digital infrastructure and systems as a prerequisite for a functioning SDM. It will support reforms to enable secure cross-border data exchange, storage, and processing to support regional deployment and access to data-driven services, innovation,

and infrastructure. It will support the development of a harmonized data and cybersecurity enabling environment, incentivizing public and private deployment of data-driven services.

- c. **Online Market Development and Integration:** This component aims to promote creation, access and delivery of digital goods and services seamlessly and freely across the region. This component aims to harmonize infrastructure and regulatory frameworks, remove barriers to cross-border access and delivery of digital goods and services, and support the creation of new digital services. The component will foster digital entrepreneurship ecosystems, harmonize technologies and legal frameworks for Digital Financial Services (DFS) aligned with international standards and achieve integration as a precursor for enabling e-commerce transactions. It will also emphasize initiatives to increase service uptake by enhancing digital literacy and skills and expanding the availability, effectiveness, and quality of key public online services for regional integration to acquaint people with use of e-services.
- d. **Project Management and Implementation Support:** This component will finance support to the recipients' project management and implementation of project-associated activities, including procurement, financial management (FM), monitoring and evaluation (M&E), project communication, environmental and social safeguards, and citizen engagement.
- 3. As part of the implementation arrangement of the project, a Project Implementation Unit (PIU) is to be established within the ECOWAS Commission which will be responsible for the day-to-day management of the project activities, as well as the preparation of annual operational, procurement, and financial plans, the drafting of contract documents, and the preparation of a consolidated implementation report.
- 4. In line with the above, the ECOWAS Commission in relation with the World Bank, plans to recruit a **Monitoring and Evaluation (M&E) Specialist** for the Regional PIU of WARDIP.

Objectives of the assignment

5. The M&E Specialist is responsible for supporting the PIU in all aspects of monitoring and evaluation of project activities with a view to ensuring that evidence is planned for and collected using the appropriate methodology and used in support of delivering project outcomes, as established in the Projects M&E arrangements and particularly in the Results Framework (RF).

6. The M&E specialist will also assist the project coordinator in the coordination of day-to-day operations of the project's activities and any other managerial function as may be assigned by the Project Coordinator.

Scope of services

- 7. The activities to be performed by the M&E Specialist include the following:
 - a. Collection and management of data for all project sub-components in a simplified manner with results-oriented indicators that are linked to the Project Development Objective and intermediate results indicators defined in the RF
 - b. Liaising with the different project stakeholders and beneficiaries to collect the necessary information to feed the RF, in accordance with the established methodologies and Project Operations Manual.
 - c. Ensure information and data from project activities are collected, analysed and reported on a timely manner in order to learn, adapt and improve project implementation.
 - d. Support the PIU Coordinator with the overall evidence-based project implementation, as well as communicating and providing analysis on findings related to the project implementation and attainment of intermediate results indicators of project development objectives, in addition to proposing and leading the strategy to adapt if needed.
 - e. Prepare and manage the budget for monitoring and evaluation activities
 - f. Prepare quarterly, semi-annual and annual progress reports, which will contain data on performance against targets, overall project recommendations and recommendations to improve both project performance and M&E.
 - g. Provide inputs to the Project Midterm Review and periodically update the monitoring and evaluation manual for the project.
 - h. Monitor project risks that could prevent the achievement of project results and their mitigation measures and related findings to PIU and implementing agency staff.
 - In collaboration/consultation with the stakeholders, monitor (i) the impact of the project,
 (ii) the quality, efficiency and effectiveness of project activities, and (iii) contribute to the quality, effectiveness and efficiency of project management processes.
 - j. Contribute to the elaboration of Terms of Reference related to project activities with a view to ensuring that the M&E criteria for assessment of activity outcomes are well spelt out.
 - k. Prepare press releases and other related communications tasks related to project activities.
 - l. Consolidate and document lessons learnt during implementation and at project completion
- 8. The M&E Specialist will work under and report directly to the Project Coordinator of the WARDIP project.

Qualifications and experience

- (i) A bachelor's degree in Economics, Project Management, Social Science or similar qualifications in line with the requirements of the position. A related Masters degree will be an advantage.
- (ii) At least five (5) years post qualification experience as an M&E Specialist;
- (iii) Three (3) years of experience in a Multilateral Donor Funded Project will be an added advantage.
- (iv) Experience in analysis of quantitative and qualitative data
- (v) Proficiency in the use of computers including word and excel processing, presentation, and spreadsheet applications
- (vi) Appropriate involvement and/or experience in similar projects in developing countries including least developed countries is essential
- (vii) Ability to find and communicate accurate information concerning processes, policies and procedures to project stakeholders
- (viii) Excellent written and verbal communication, and presentation skills.

Duration

The M&E Specialist will be appointed for a period of two (2) years, renewable based on availability of budget and satisfactory performance.
