INTRODUCTION

The Economic Community of West African States (ECOWAS), a Community of some 230 million citizens, was established on the 28th May, 1975 through the Treaty of Lagos, Nigeria, later revised in 1993.

The 15 Member States that comprise the Community are Benin, Burkina Faso, Cape Verde, Cote d'Ivoire, The Gambia, Ghana, Guinea, Guinea Bissau, Liberia, Mali, Niger, Nigeria, Senegal, Sierra Leone and Togo.

Its headquarters is located in Abuja, Nigeria.

In 2007, the administrative structure of the Community was re-organised with the transformation of its defunct Executive Secretariat into a nine-member Commission of a President, Vice President and Seven Commissioners, who are expected to provide strategic leadership in realising its Vision 2020 for a citizen-focused organisation.

VISION

To create a border less, peaceful and cohesive region built on good governance and where the people have the capacity to access and harness its environs resources through the creation of opportunities for sustainable development and environmental preservation.



OBJECTIVE

To promote cooperation and integration, leading to the establishment of an economic and monetary union in West Africa in order to raise the living standards of its people and to ensure economic growth, foster relations among Member States and contribute to the progress and development of the African continent.



EARLY WARNING

Establishment of an ECOWAS Warning and Response Network (ECOWARN)

This comprises a database built on conflict indicators and accessible via the Internet and supported by 1) a network of state and civil society focal points for dissemination through incident and situation reporting, 2) the zonal bureaus and civil society desk officers who coordinate national activities and provide the first level of quality control and 3) the situation room in the Commission tasked with the management and analyses of information and the provision of various reports to support early warning and response activities.

- Development of modules to support early warning and response activities;
 - ECOWAS Peace Exchange: An online database forum for the exchange of commentaries, narratives and unstructured observations between the field reporters, other identified civil society organizations and expert institutions.
 - Geographic Information Systems: An integrated system designed to support analysis and response through 1) timely information from spatial and non-spatial data integration relating to flash points in Member States
 coordinated, analysed and processed data received from Earth Observation Satellites and ground-based information 3) Decision Support Systems (DSS) for troop deployment in time of war/social crises
 environmental, human-related disasters and security-related information
 - Video Conferencing Communication Network between the Early Warning Centre in Abuja and the zonal bureaus is scheduled for development. (The network funded by the African Development Bank (ADB) would enhance



real time communication between Member States and the various ECOWAS Communities)

- Production of early warning and response products for use by ECOWAS decision-makers
- Engagement with the African Union in the set up of the Continental Early Warning System (CEWS)

There will be conscious and sustained collective efforts to eliminate social discrimination or exclusion, and there will be a demonstrable strong drive to inculcate acceptance of the socio cultural diversities of the region as a positive factor that enriches life in the region.

GOVERNANCE

We envision by 2020, a unified region that is integrated into the continental and global economic space and governed using the principles of good political and economic governance, transparency, and accountability in the use of public resources and where fundamental human rights are protected respected.

ECONOMIC AND MONETARY INTEGRATION

We envision by 2020: a single unified regional market with a common currency supported by an integrated and efficient financial market and payment settlement system; an ECOWAS of people where trade and commerce are conducted efficiently and with ease.

PRIVATE SECTOR

We envision by 2020, an ECOWAS of people with a conducive policy environment in which the private sector will be the primary engine of growth and development; an integrated regional production base developed by competitive private sector activities which provide production and distribution levers for deeper regional integration and development, supported by an efficient ECOWAS business body that promotes public private partnerships for generating wealth to sustain the development and prosperity of the region.
