Bids (1 original and 3 Copies) SHALL be delivered in a sealed envelope clearly marked "Regional Competitive Bidding for the supply of tools and training of Digital Forensics Laboratory (DFL) team in Liberia" Do Not Open, Except in Presence of the OPENING COMMITTEE. The envelope SHALL also indicate the bidder's name.
