The Bids, consisting of one (1) original and three (3) copies, must be deposited at ECOWAS Commission, 101 Yakubu Gowon Crescent, Asokoro District, Abuja, Nigeria, Directorate of Administration and General Services, Office of the Procurement Division, 1st Floor, no later than 11:00 a.m. (local time, GMT+1) on May 28, 2025. Bidders are also invited to submit an electronic copy of the bid on a USB flash drive (PDF and Excel sheet for price tables), which will be provided at the same time as the physical bid. The USB flash drive containing the electronic copy must be inserted in the sealed envelope.

Bids submitted after the deadline for submission of bids shall not be accepted by the Bid Opening Committee and shall not be opened.

- 6. Bids should be clearly marked ICB: **PP-W-2025- 002 Renovation and modelling of ECOWAS Liaison Office at Lagos** "do not open, except in the presence of the opening committee", and should comprise a technical bid in line with the description of services; and a financial bid including all services charges and discount supported or offered by the bidder (exclusive of taxes). The envelope SHALL also indicate the bidder's name.
- 7. Bids must include an original bid guarantee of US dollars ten thousand (10,000) issued by a reputable commercial bank. The bid guarantee will be valid until the 28th day following the deadline for the validity of the bid.
 - All bids received on time will be opened on the same day in the presence of representatives of bidders who wish to attend. Tenders will be opened at the place of physical deposit and online.
- 8. Bids shall remain valid for a period of **120** days from the submission deadline.
