Method of Contracting: Regional Tendering

1. The **ECOWAS Water Resources Management Centre (WRMC)** has obtained an allocation from the investment budget for the year 2025 to finance various works and intends to use part of this allocation to make payments under this Contract.

2. The **ECOWAS Water Resources Management Centre (WRMC)** is soliciting bids from eligible candidates who meet the required qualification criteria for **the construction of nineteen (19) solar-powered Autonomous Water Stations (PEAs) in various localities in the Republic of Guinea**. The works are made up of a **single lot** bringing together the following localities:

Tambabougou; Tando; Fodécariah; Foussen; Komodou 1; Manséréna Banakoro; Biakourou; Lani; Gbanworla; Sindjan Sokourala; Kamara; Kadabayah; Kouroukoro Fassoumaya; Sandafra; Kebeya; Gadha Songoussa; Bimbirico; Fello Ferobhé; Salamayo.

The work must be carried out within **eight (08) months** from the date indicated in the service order for the start of services.

Bidders must be encrypted with a password that will only be communicated on the day and at the time of the tender opening.

The deadline for the submission of bids is Thursday, october 2, 2025 at 09:00 a.m. GMT.

7. Bids must include the original of an offer guarantee in the amount of **five million (5,000,000) CFA francs issued by a reputable bank**. The offer guarantee will be valid until the 28th day following the offer expiry date.

All bids received on time will be opened on the same day (**Thursday, october 2, 2025**) at **09:30 a.m. GMT** in the presence of the representatives of the bidders who wish to participate. **The opening of the offers will take place online.**

8. Bids will remain valid for a period of **120 days** from the submission deadline.
