Title of the Contract: **CONSTRUCTION OF SEVEN (07) SOLAR-POWERED AUTONOMOUS WATER STATIONS IN VARIOUS LOCALITIES IN THE REPUBLIC OF CAPE VERDE**

Procurement method: **Regional call for tenders**

1. **Water Resources Management Center of ECOWAS** obtained for the year 2025 an allocation from the investment's budget in order to finance the procurement of various works of **construction of Autonomous Water Stations** and intends to use part of this allocation to make payments under this Contract.
2. **Water Resources Management Center of ECOWAS** invites sealed bids from eligible and qualified Bidders to provide works for the construction of seven (07) solar-powered Autonomous Water Stations (AWS) in various localities in the Republic Cape Verde; consisting of a **single lot** as follows:

**CABECA DOS TARRAFES ; FUNDOS DAS FIGUEIRAS ; JOÃO GALEGO ; FONTES ALMEIDA ; GUDIM ; MENDES FALEIRO RENDEIRO ; VALE DA CUSTA**

The contact details of the locations are specified in the tender documents.

The work must be completed within **seven (07) months** of the date indicated in the service order for the start of the services.

4. The award of the Contract will be conducted by Regional Invitation to Bid as defined in the Revised ECOWAS Procurement Code (Annex 1 to 8) and open to all eligible candidates. The qualification requirements are set out in the Tender Documents, in this case in Articles 4, 36 and 38 of the Instructions to Tenderers.

In case of electronic submission, bidders are invited to take all necessary measures to avoid any technological failure that could lead to delays and/or errors when submitting electronically. The original bid guarantee must be delivered to the contracting authority no later than the deadline for submission of bids (ECOWAS Commission, 101 Yakubu Gowon crescent, Abuja, Nigeria. 1<sup>st</sup> floor, Procurement Division).

Bidders must be encrypted with a password that will only be communicated on the day and at the time of the tender opening.

**The deadline for submission of tenders is Tuesday, April 21, 2026 at 11:00 a.m. GMT.**

Bids submitted after the deadline for submission of bids shall not be accepted by the Bid Opening Committee and shall be returned to their holders unopened.

7. Bids must include an original bid guarantee of US dollars ten thousand (10,000) issued by a reputable bank. The bid guarantee will be valid until the 28th day following the deadline for the validity of the bid.

All bids received on time will be opened on the same day (**Tuesday, April 21, 2026**) at **11:30 a.m. GMT** in the presence of representatives of bidders who wish to attend. **Tenders will be opened online.**

8. Bids shall remain valid for a period of **120** days from the submission deadline.
